Once known for wild living, Austin's on-the-edge defense lawyer has settled down with wife, baby and vineyard, but in court he still sinks his teeth into the prosecution

Joe Turner takes it all personally. So he showed recently when he posed for a front-page photo with client Paul Saustrup, whose shooting of a would-be truck burglar on a downtown street is the latest in Turner's series of high-profile criminal cases, cases that he has done his best to turn into tests of character.

defendant is," said the intensely animated, 43-year-old dynamo of a defense lawyer, arms flailing as he makes his point, while his ruddy complexion grows even more heated. "If I like him, the jurors are going to like him, because I'm going to sell him. And if they like him, then he has a pretty good chance of winning—regardless of what the facts are, regardless of what the law is. It all comes down to character, and I think that jurors are pretty good judges of character."

Turner himself is something of a character. He took it personally in 1975, when the University of Texas law school declined to admit him, until Turner persuaded a federal judge to intervene. He took it personally during his

He took it personally during his five years as a prosecutor, from the late '70s through the early '80s, when his aggressiveness earned him the nickname "Mad Dog." He grew increasingly frustrated with government work when he saw others rewarded on the basis of senior-

ity, while he was running rabid rings around them in terms of trials and convictions.

He takes his birthdays very personally. For his 30th, he flew the blues legend Big Joe Turner into town and threw a party at Antone's, where the two Joe Turners shouted "Shake, Rattle and Roll" onstage. For his 40th, he hired another Joe — Ely — to play a bash at Turner's Oak Hill ranch, where the
