

CITY OF LOOKOUT MOUNTAIN, GEORGIA

ORDINANCE NO. 293

AN ORDINANCE to amend the City of Lookout Mountain, Georgia’s Ordinance No. 193, to reduce the speed limits on certain portions of Lula Lake Road in the City of Lookout Mountain, and for other purposes.

WHEREAS, the speed limits on Lula Lake Road, as established in the City of Lookout Mountain’s Ordinance No. 193 are currently as follows:

WHEREAS, the City Council of the City of Lookout Mountain has determined that, for reasons of public safety and welfare, the speed limit applicable to all of Lula Lake Road should be uniformly set at 25 miles per hour.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and IT IS HEREBY ORDAINED:

SECTION 1. Section 1 of the City of Lookout Mountain’s Ordinance No. 193 is hereby amended by the deletion therefrom of the table of “Off System” roads currently set forth therein and the substitution therefor of the following:

In all other respects, Ordinance No. 193 (including but not limited to Section 1 of said ordinance) will remain in full force and effect, unaffected by this amendment. The only change to Ordinance No. 193 intended by the City Council is the creation of a uniform speed limit of 25 miles per hour for all of Lula Lake Road.

SECTION 3. If any of the sections, subsections, sentences, clauses or phrases of this Ordinance are for any reason held to be unconstitutional or invalid, the validity of the remaining portions of this Ordinance shall not be affected, since it is the express intent of the Council of the City to pass each section, phrase, paragraph and word separately.

SECTION 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5. This Ordinance shall be effective ten (10) days after its adoption and approval by at least three (3) members of the Council of the City after two (2) readings at least one (1) week apart.




