ORDINANCE NO. 65

AN ORDINANCE

To repeal in its entirety Ordinance No. 45 of the City of Lookout Mountain, Georgia, agreeing and subscribing to the Insurance Trust Agreement by and between the Georgia Municipal Association, Inc., the Trustees named and provided for in the Agreement and the City.

WHEREAS, the City of Lookout Mountain, Georgia has elected to participate in an insurance program other than that adopted by Ordinance No. 45 of the City of Lookout Mountain, Georgia.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:


Section 1. Ordinance No. 45 of the Code of Ordinances of the City of Lookout Mountain, Georgia is hereby repealed in its entirety.

Section 2. This Ordinance shall be effective ten (10) days after its adoption and approval by at least three members of the Council of the City after two readings at least one week apart.

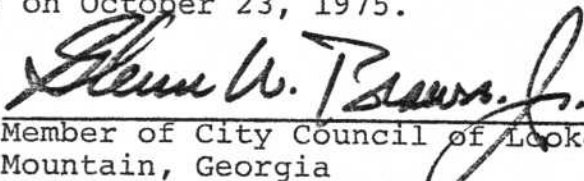

BE IT ORDAINED by the City Council of the City of Lookout Mountain, Georgia, and it is hereby ordained:

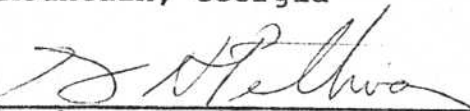

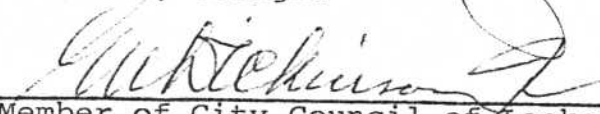
