

Terms and Conditions

- Happy Travels and its agents, in providing consultations, making reservations, and issuing any travel documents relating to travel or transportation are acting solely in their capacity as agents for the carrier, tour company, transfer company, resort or hotel. Happy Travels shall assume no responsibility or liability for actions beyond its own control in connection with the service to be provided. Happy Travels is not responsible or liable for any act, error, omission, injury or default, or any action of the tour company, airline, transfer company, resort or hotel, or person engaged in carrying out the purpose for which travel documents have been issued.
- Happy Travels shall not be responsible for any injuries, losses or damages in connections with terrorist activities, social or labor unrest, mechanical or structural integrity of air, changes in airline seating, and ground transportation and accommodations, diseases, local laws, terrorist acts, bankruptcy or cessation of supplier or carrier services, climatic conditions, acts of God, delays, changes or cancellation of travel due to weather conditions, hotel services, accidents or health related problems before or while in-transit, during or after a tour, or any other actions, omissions, or conditions outside of Happy Travels control.
- When traveling to another country, it is the traveler's responsibility to determine entry/health immunization requirements.
NOTE: anyone planning to travel outside of the United States - even entering a port of a foreign country (including Canada), while on a cruise - who has any type of criminal record (including, but not limited to, convictions for DUI/DWI) should take particular care when investigating and determining the laws and immigration guidelines of the foreign countries to ensure that the traveler is eligible for entry.
- VALID PASSPORT BOOKS (not passport cards) ARE REQUIRED FOR ALL TRAVELERS, REGARDLESS OF AGE FOR INTERNATIONAL TRAVEL.
****There must be at least 6 months validity from the return date of the trip. ****
Traveler assumes full responsibility for checking and verifying any and all passport, visa, vaccinations, or other entry requirements of countries included on their travel itineraries. It is the responsibility of the passengers to give legal correct full passport names at time of booking international reservations, or Driver's license or passport names for domestic travel. Passengers may be denied boarding if names are not correct. Name changes are at the expense of the traveler.
- It is the traveler's responsibility to protect their purchases and Travel Insurance is strongly recommended. Traveler is advised to obtain appropriate insurance coverage against penalties if reservations are cancelled. Information concerning insurance is available through the travel agency. However, no representation or description of the insurance made by our staff constitutes a binding assurance or promise about the insurance. Traveler's retention of tickets, reservations, or bookings after issuance shall constitute consent to the above and an agreement. By embarking upon his/her travel, the traveler voluntarily assumes all risks involved in such travel, whether expected or unexpected.
- Airline tickets are nonrefundable. Airline reservations should be reconfirmed directly with the carrier 24 hours prior to travel in case of any schedule changes that may occur. Most airlines are now charging a fee for all checked baggage. Rules vary per Airline.
- I have reviewed the reservation made on my behalf by Happy Travels including, but not limited to, the names, birthdates, and dates of travel and I agree that they are correct.
- Trip cancellations must be in writing. Refunds can take up to 12 weeks to process. I understand that *Happy Travels* is not responsible for any cancellation by me, or errors, omissions, or cancellation by vendors providing travel services as a result of this reservation. I have read and understand the cancellation/amendment policies of the vendor's travel program that I have purchased. I agree to pay all charges, fees, and penalties, and hereby hold *Happy Travels* harmless and free of any claims made as a result of the changes/cancellation of this travel reservation. In addition, I understand that *Happy Travels* will assess a \$50 fee per person as a result of the cancellation of this transaction. This cancellation payment, if incurred, will be processed automatically through Paypal.
- Your signed charge authorization is a binding agreement for charging your card, and as such you waive any right to a chargeback in the case of trip delays, changes, or cancellations for any cause (excepting fraud), including a force majeure event, and you agree to refund policies and procedures as outlined in the terms and conditions of the suppliers operating components of your trip. In the event that you attempt without our authorization to chargeback, reverse, or recollect a trip payment already made, we reserve the right to collect all additional costs, fees, and expenses associated with such chargeback, reversal, or recollection including, without limitation, attorney fees.
