RULES

As a contestant in the Miss Western Days Queen's Review Pageant, I hereby agree to the following:

1. I am a female and currently a freshman, sophomore or junior in a High School program.
2. I am at least 14 years of age and under 18 years of age.
3. My current permanent and primary residence is within the Elgin Independent School District boundaries.
4. I am not now and have never been married, pregnant, a parent, nor have I had a marriage annulled.
5. I am of good moral character and have not been convicted of any crime other than a traffic violation or misdemeanor not involving moral turpitude.
6. I agree that as a participant in the Miss Western Days Queen's Review Pageant I will abide by all rules and guidelines governing that pageant.
7. I understand and agree that the Greater Elgin Chamber of Commerce Miss Western Days Queen's Review Pageant Committee shall determine all issues as to eligibility and I agree to abide by that determination both as to myself and other applicants.
8. I agree that if selected to represent Elgin in the Miss Western Days Queen's Court, I will participate in the Western Days festivities, the annual Chamber of Commerce Banquet, at least three local area parades and as many other requested appearances as possible.
9. I understand that if I am selected as Queen, the Greater Elgin Chamber of Commerce will notify me of the time and date of parades in Elgin and surrounding communities and I agree to be responsible for notifying the rest of the court.
